An Orchestra means performance of artists singing and/or playing various musical instruments without any type or kind of dance.

## Conditions

१. This licence is valid for one stage of १० $\mathrm{ft} \mathrm{X} १ २ \mathrm{ft}$ only on ground floor.
२. All conditions of the Health Department and the Chief Fire Officer should be followed at all times.
३. Sufficient number of Entry and Exit doors should be operative at all times for free safe and Unobstructed movements of the visiting customers. Conditions as laid down in Noise PollutionControl Rules be strictly followed.
૪.There should not be any nuisance to the residents in the area.
4.The licence should not allow his customer to park their vehicles on the road, causing traffic Problem. If any traffic problem arises, without notice the licence shall be cancelled.
६.
